# General Information

## Am I Eligible

### Domestic Students

All registered Full-time Domestic undergraduate students taking 9 credits or more (3 courses) are required to have health insurance coverage, either through this Student Health Insurance Plan or through another individual or family plan. Students are automatically enrolled in the Student Health Insurance Plan at registration and the premium is added to the student's tuition fees unless proof of comparable coverage is provided by completing the waiver.

### International Students

All registered Full-time International students taking 9 credits or more (3 courses) are required to have health insurance coverage. Students are automatically enrolled in the Student Health Insurance Plan at registration and the premium is added to the student's tuition fees and do not have the option to waive coverage.

### Dependents

Dependents are not eligible.
